## **MINUTES OF MEETING**

It was attended by Dr. Nipul Vara, Dr. Yogesh Marfatia, Dr. Chirayu Bardoliwala, Dr. Ajay Parikh, Dr. Jagdish Sakhiya, Dr. Krina Patel, Dr. Jitendra Modi, Dr. Suresh Patel, Dr. Yogesh Bhingradia, Dr. Janak Thakkar and Dr. Rashmi Mahajan.

- 1. Dr Rashmi Mahajan welcomed all the EC members.
- 2. **AGENDA 1**: Minutes of meeting of AGBM held on 20<sup>th</sup> December 2020 were read out.
- 3. **AGENDA 2**: Discussion regarding community dermatology programme Village adoption in various districts

Dr Y S Marfatia Suggested that Community Development Programme should be started by adopting a village within 30-40 kms of city limits. Monthly camps can be conducted by faculty and residents of medical colleges in association with local medical practitioners and this should continue long term.

Dr Krina Patel suggested that it should be tied up with various PHCs in order to ensure smooth functioning of the program.

Dr Janak Thakkar raised the issue to how long the program can be continued?

Dr Ajay Parikh inquired the criteria for village selection.

It was suggested by Dr Jagdish Sakhia that the village can be decided by the local dermatology associations and may be commensed with the four larger associations of Surat, Ahmedabad, Vadodara and Rajkot. Later it could be adapted by other cities as well.

This was unanimously agreed upon.

Dr Y S Marfatia suggested we should follow the central IADVL guidelines and declare the name of the President elect for the forthcoming year. Further, the term of the Secretary and Treasurer should be 2 years. He also suggested this point may be taken up in the an extraordinary GBM. Dr Suresh Patel expressed concern regarding the same as coordination would be difficult between the President and Secretary if they were from

Dr Krina Patel expressed that the same system is being followed at the National Level also.

Dr Jitendra Modi suggested that the President has to be zone wise.

Dr Jagdish Sakhia suggested that it is better to follow the older system of 1 year term for both president and secretary.

Dr Y S Marfatia suggested that this point could be taken up in an Extraordinary AGBM

There was no final consensus decided on this issue.

5. **AGENDA 4**: Formation of IADVL GSB Academy – suggestions

Dr Y S Marfatia suggested that an IADVL GSB Academy Group be created to coordinate the various academic activities held in Gujarat.

The group should comprise 2 coordinators from Medical colleges of different zones, of 2 years term and 10 members, 2 from each zone (five from medical colleges and five private practitioners) with 1 year term.

Dr Janak Thakkar said that Private practitioners can also be coordinators for the same, upon which Dr Krina Patel stated that it would be better that coordinators are from medical colleges as this requires commitment and time from the coordinator. It was then decided that while one coordinator will be from a medical college, the other may be a private practitioner.

6. **AGENDA 5**: CPS issue – report of deliberations in General Body meet held on 6<sup>th</sup> February 2021 to arbitration committee.

Dr Rashmi Mahajan requested permission from the EC Members to send a report of the deliberations of the proposal regarding the CPS issue that was discussed in the AGBM 2021 in e-DERMACON to the arbitration committee
